Congressional Update - by Tom Troxel

We're tracking two bills, plus Forest Service Fire Funding legislation and FY 2018 Appropriations:

H.R. 2936 - Resilient Federal Forest Act of 2017 Introduced by Rep. Bruce Westerman, the only professional forester in Congress, with bi-partisan co-sponsors, including Rep. Scott Tipton (CO-3). Expanding upon provisions from the 2014 Farm Bill, the bipartisan bill provides new categorical exclusions to the Forest Service, reduces unnecessary NEPA and ESA bureaucracy for a



wide variety of projects, provides relief from the Cottonwood court decision, and gives the Forest Service access to emergency fire suppression funds. It also includes an innovative pilot program to test binding arbitration as an alternative to litigation, and provides authorization for 16 and 17-year olds to work in family run logging businesses.

Sen. Daines (MT), this bill would amend the Forest and Rangeland Renewable Resources Planning Act of 1974 and the Federal land Policy and Management Act of 1976 to prohibit the Department of Agriculture (USDA) or the Department of the Interior from being required to engage in any additional consultation with respect to: (1) the listing of a species as threatened or endangered, or a designation of a critical habitat, if a land management plan or land use plan, respectively, has been adopted by USDA or Interior as of the date of the listing or designation; or (2) any provision of such an adopted plan.

FY 2018 Forest Service Appropriations On July 18, the House Appropriations Committee approved the Interior Appropriations Bill, which includes funding for the Forest Service; details include - \$3.4 billion went to fire suppression, \$370 million for timber management which is an increase of \$2 million with a national target of 3.2 billion board feet, direction to discontinue Integrated Resource Restoration funding, and Hazardous Fuels funding to be transferred to the National Forest System from State and Private Forestry.

Congressional Update - Continued

S. 1571 - Re-authorization of the National Flood Insurance Program

Interestingly enough, Section 102 of this bill adds a new title to the Stafford Disaster Relief and Emergency Assistance Act, which requires Congressional fire suppression at 70% of the 10-Year Average, requires Congress to fund projects that reduce fire potential at 30% of the 10-Year Average, prohibits transfer of non-fire funds to fire suppression accounts, and authorizes funds from the Disaster Relief Fund with a presidential declaration.

CTIA strongly supports Congress legislation that meets the following criteria to address the FS's Fire Funding problem 1) Eliminate any need for 'fire borrowing' to ensure forest management funds are not diverted away from implementing essential projects on-the-ground, 2) Stop further increases in the percentage of the Forest Service's budget designated for fire suppression, 3) Increase proactive forest management and fuels reduction programs as means of reducing the potential for catastrophic fires through additional funding and/or streamlined analysis requirements.

If you happen to see your Congressional representatives during the August recess, please take a minute to ask them to support these bills.

Fire Funding Trivia - as of July 21, 4.5 million acres have burned this year, compared to an average of 3.3 million acres over the last 10 years.

Governors Weigh-In

The Western Governors Association recently approved a very positive resolution regarding National Forest and Rangeland Management. Some excerpts from the resolution include –

- Western Governors support sound forest management policies that maintain and promote ecologic, economic and social balance and sustainability.
- Western Governors ... believe it is reasonable to expect that some portion of the federal landscape will be focused on long-term, ecologically-sound forest management where jobs, forest products, and revenues are priorities and generated through sound stewardship.
- Western Governors encourage federal agencies to fully implement the tools provided in the 2014 Farm Bill.
- The impacts of forest management are felt most directly by those who live, work, and recreate in and adjacent to those forests, so the discussion needs to begin there.



Colorado Water Report

As a result of legislation in 2016 (HB 16-1255), the Colorado State Forest Service in conjunction with the Colorado Department of Water Resources, put together a supplemental report to the Colorado Water Plan. This report highlights the effects of wildland fire, insect and disease outbreaks, a changing climate, and roads and human disturbances on Colorado's forests and water supply. The objective of this document was to bring to light more information on the devastating effects wildland fire can have not only on our forests, but our watersheds and communities as well. Hot Off the Press



A new publication from the Forest Service Rocky Mountain Research Station, "Colorado's Forest Resources, 2004-2013", RMRS-RB-23, contains a wealth of information about Colorado's forests, including forest land ownership (49% is managed by the US Forest Service), Forest Type (#1 is Pinyon-Juniper, #2 is Spruce-Fir, #3 is Aspen-Birch), Stand Age, Numbers of Trees, Tree Volume (32% is/was Spruce-Fir), Growth and Mortality (yep, lots of mortality), Removals, Forest Industry Facilities, Snags, etc., etc. While this is the most up-to-date information available, it is already somewhat dated due to the rapid spread and massive

SB 17-302

During the past legislative session, Senator Coram and others passed Senate Bill 17-302, which finally clarified the issue of what is considered silvicultural equipment for the purposes of property tax exemption. According to the bill,



silvicultural equipment is "silvicultural personal property that is designed, adapted, and used for the planting, growing, maintenance, or harvesting of trees in a raw or unprocessed state." This clarification was necessary because some counties in the state where not allowing the property tax exemption for silvicultural equipment, while other counties in the state were giving the exemption. CTIA would like to thank Senator Coram and the others who cosponsored the bill for getting this Senate Bill passed.

2017 Colorado Outstanding Logger of the Year

Congratulations to Mike Jolovich with Windy Gap Logging, who was chosen by the Colorado Tree Farm Committee as the 2017 Colorado Outstanding Logger of the Year.


Here are some words from the nomination: Even though Windy Gap Logging is a relatively new logging company established in 2014, Mike Jolovich has been producing forest products in Grand County since 1992 as the founder and General Manager of Ranch Creek Ltd., a local sawmill just outside the town of Granby. Windy Gap Logging has two employees (Mike and Steven) who operate a John Deere 759G harvester, a Cat 525 skidder, and a D6 dozer. Windy Gap Logging in conjunction with Ranch Creek Ltd. produces a variety of wood products including fencing, house railings, paneling, packing material for pipes, dimensional lumber, log cabin packages and firewood. The diversity of wood products produced allows Mike to utilize a very large percentage of timber (and blowdown) from the timber sales he purchases, maximizing the efficient usage of forest resources.

The reasons why Mike is an outstanding logger/contractor: Mike is one of the friendliest guys in the woods – an absolute pleasure to work with! Administering a timber sale that he is cutting is easy, always enjoyable and educational. He continually seeks, and is responsive to, constructive feedback on how best to meet the project objectives and he is happy to share how the local conditions and contract requirements affect his operations without complaint. There is seldom any work that needs to be corrected. Mike takes great care of his equipment and employees, which equates to quality work, little down time, and deadlines met. Mike's work ethic is also well demonstrated in his land ethic as he cares for the land through his work on the ground. Whether it is the protection of advanced regeneration, excellent utilization, or adherence to BMP's, Mike's work is top notch!

Member Spotlight Rocky Mountain Timber Products and Entermountain Enterprises, Inc.

Cassandra Doyon, along with her husband Richard, have owned and operated Entermountain Enterprises, Inc. and Rocky Mountain Timber Products since 1985. Located outside of Del Norte, Colorado, Entermountain Enterprises is the logging side of the business, whereas Rocky Mountain Timber Products is the manufacturing/ sawmill piece of the equation.

Rocky Mountain Timber Works has a sawmill capacity of about 5 million board feet, but they typically run about 3 million board feet a year depending on supply and availability of help. In addition to regular surfaced dimensional lumber, they also produce rough-cut lumber, custom beams, tongue and groove paneling, tongue and groove house siding, decorative railings and posts, firewood, and mulch. They utilize a variety of species including spruce, white fir, ponderosa pine, and aspen. Rocky Mountain Timber Works currently employs 6 employees.

Entermountain Enterprises does most of their harvesting on the Rio Grande National Forest, but occasionally goes over the divide onto the San Juan National Forest. This part of the operation has 3 employees.

Doyons have been a CTIA member since the organization got started and are also a proud member of the Intermountain Forests Association. Cassandra and Richard have two daughters who are both grown, and they are anxiously expecting their first grand child.


Healthy Forests Healthy Communities
