Business Meeting

IFA/CTIA Transition By Tom Troxel

Yes, after 28 years, I really will be retiring from the Intermountain Forest Association at the end of December. I have enjoyed working with many of you over the years, and I have very mixed emotions about retiring. After a nationwide search, the IFA Board has hired Ben Wudtke, who currently works for the Black Hills Forest Resource Association out of the same office, as the new IFA Executive Director. Ben has been working with us for 5 years and he has a good understanding of the issues, and will do a great job. The IFA Board has also decided to increase Molly Pitts' responsibilities for national forest related issues in Colorado. I have recommended that the CTIA Board hire Molly as the new CTIA Executive Director, and that will be an agenda item for the December 6 CTIA Board Meeting. Molly has been contracting with IFA and CTIA for the past 2 years, and has a good understanding of issues and good working relationships with many CTIA members, and she will also do a great job. I will be working with both of them on transition details between now and the end of December, and later as needed. I'll also be continuing to staff the Federal Timber Purchasers Committee and continue as a member of the National Forest Planning Advisory Committee through 2018. Thank you all for the privilege of working with you, and I hope we'll continue to cross paths.



Fire Funding

2017 has been a very costly fire season – in acres and in costs. About 8.5 million acres burned on all ownerships and the Forest Service's cost to fight those fires was a record \$2.7 billion. The Forest Service had to "borrow" about \$525 million from other accounts, which the Congress has already repaid.

You've all seen the statistics about how the fire budget was about 16% of the Forest Service's budget in the early 1990s, but now it's over 50% of the Forest Service's total budget. The Forest Service's budget gurus now estimate that the fire budget will make up 2/3 of the Forest Service's budget by 2021 – that will squeeze funding for all other programs including timber management and fuels management, the very programs that are needed to help reduce the potential for catastrophic fires. CTIA's position on Fire Funding is –

- Eliminate the need for 'fire borrowing' to ensure forest management funds are not diverted away from implementing essential projects on-the-ground.
- Stop further increases in the percentage of the Forest Service's budget designated for fire suppression.
- Increase additional forest management and fuels reduction programs as means of reducing the potential for catastrophic fires through additional funding and/or streamlined analysis requirements similar to Westerman Bill.

If you see any members of the Colorado Congressional delegation or their staff, thank them for their support on fire funding, and ask them to do everything they can to get a Fire Funding package that achieves CTIA's position completed and to the President's desk – this year!!



Meeting w/ Regional Forester Brian Ferebee

On August 28, Tom Troxel, Molly Pitts, and several IFA/CTIA members met with Regional Forester Brian Ferebee, Deputy Regional Forester Jacque Buchanan, and Natural Resources Director Steve Lohr in Denver.

Brian expected the Region to meet or exceed their FY 17 target, and expected the FY 18 target to be about 600,000 ccf. They have work to do on funding and staffing, but will start the new fiscal year as though they have the money and the people. Brian also discussed "NEPA Modernization" and "Forest Management Modernization" Washington Office initiatives. He also discussed the importance of a fire funding 'fix' to help resolve funding issues with roads, landlines, etc. for timber sales. Troxel reviewed IFA's three criteria, and Ferebee agreed. Other discussion items were objections, precommercial thinning, and forest planning.

The preliminary numbers are in, and most of Colorado's national forests met or exceeded their timber program targets in FY 2017. National forest timber is vital to Colorado's forest products companies, and we appreciate all of the work that went into their accomplishments, especially on the Forests that met or exceeded their targets. CTIA's goal is that all of the national forests in Colorado will meet or exceed their FY 2018 targets, plus any shortfall from FY 2017.

The Forest Service's FY 2018 budgets and targets have not been finalized yet, but the tentative sale program target for the Rocky Mountain Region, which includes national forests in Wyoming and South Dakota, is 600,000 ccf, compared to 562,000 ccf in FY 2017.



Colorado Forest Health Advisory Council

The Forest Health Advisory Council (FHAC) was created by HB16-1255 to provide a collaborative forum to advise the State Forester on a range of issues, opportunities and threats with regard to Colorado's forests. The FHAC has identified the following as priority items.

Regional Approach to Forest Health Management: The FHAC is actively promoting this regional approach to Forest Health Projects being implemented on the ground through working directly with the Basin Roundtables and the wide range of local partners associated with the Basin Roundtables. The FHAC is working at comprehensive list of these partners and assessing how to best work together to further forest health in Colorado.

Expand Local Funding to promote Forest Health: The FHAC promotes the need to incentivize and fund forest management activities at the watershed level that are necessary to alter landscape-level forest health in the headwaters of Colorado and support Colorado forest product businesses. The FHAC would like to see the legislature make a robust expansion of funds for forest health projects.

Governmental Immunity for State Agencies to Conduct Prescribed Burns: The FHAC supports the use of prescribed fire as a matter of risk management when compared to wildfire and recognizes that certain CSFS personnel have unique qualifications and experience relating to wildfire management that are not currently being utilized, particularly with regard to pile burns. The FHAC is currently discussing the merits of governmental immunity for State and local agencies to facilitate the use of prescribed fire to conduct prescribed burns on State and private lands.

<u>Timber Industry in Colorado</u>: The FHAC encourages agencies to prioritize creating a consistent, long-term timber harvesting program across the State. The cost of biomass removal or utilization per acre is very high due to lack of wood products businesses, particularly in Colorado's rural areas. The FHAC supports utilizing and incentivizing the timber industry as part of the solution to decreasing the cost of treatment.

Forest Plan Revision

After months of anticipation, the Rio Grande National Forest finally released both the draft Forest Plan and draft EIS in early October. Comments are due January 2nd, 2018. The GMUG announced in early summer that they were entering Forest Plan Revision. After hosting a series of public meetings in late summer, they are expecting to release draft Assessments on November 6th. There will be a 30-day comment period. 
